# KNOW YOUR RIGHTS: AVOIDING MISUSE OF PSYCHOTROPICS FOR NURSING HOME RESIDENTS



Nursing home residents with dementia and other cognitive disorders are frequently given psychotropic medications, often involuntarily, to control a resident's behavior. This is known as chemical restraint.

### THE FEDERAL NURSING HOME REFORM LAW GUARANTEES YOUR RIGHT TO:

- Be free from physical or chemical restraints imposed as discipline or for convenience and not required to treat medical symptoms
- · Request, refuse, and discontinue treatment
- Participate in preparing a person-centered plan of care
- Be fully informed in advance of care and treatment to be provided, including the risks and benefits of treatments

#### FLORIDA LAW REQUIRES:

- The use of chemical restraints to be consistent with a resident's diagnosis
- A resident or their representative to be informed of a facility's chemical restraint policies and procedures during admission

#### SOME QUESTIONS TO ASK WHEN MEDICATION IS PRESCRIBED

- · Why was this drug ordered?
- Is this medication approved to treat my symptoms or illness?
- What alternative non-medication options are available?
- What are the side effects and risks of this medication?

## SIGNS OF IMPROPER PSYCHOTROPIC USE

- · A significant change in behavior
- Agitation and anger
- Screaming, swearing
- Hitting and pacing
- · Confusion, paranoia, delusions
- Continuous wandering
- Lethargy, decreased appetite, insomnia

## Improper Use of Psychotropic Drugs Can Cause Serious Medical Complications:

- Over-sedation
- Confusion
- Respiratory infections
- Falls
- Strokes
- Death

#### PSYCHOTROPIC DRUGS COMMONLY USED AS CHEMICAL RESTRAINTS

- Risperdal (Risperdone)
- Zyprexa (Olanzapine)
- Seroquel (Quetiapine Fumarate)
- Geodon (Ziprasidone Hydrochloride or Mesylate)
- Abilify (Aripiprazole)
- Invega (Paliperidone, Paliperdone Palmitate)
- Haldol (Haloperidol)
- Moban (Molindone Hydrochloride)
- Navane (Thithixene)
- Orap (Pimozide)
- Symbyax (Fluoxentine Hydrochloride, Olanzapine)
- Clozaril (Clozapine)
- Fazaclo (Clozapine)
- Depakote (Divalproex Sodium)
- Ativan (Lorazepam)
- Paxil (Paroxetine)
- Nuedexta (Dextromethorphan-Quinidine)
