## About the Conference

The Florida Poverty Health Law Conference convenes legal aid attorneys and allied advocates from across Florida for practical trainings on healthcare rights and remedies for low-income clients. Sessions emphasize Medicaid, CHIP/KidCare, long-term care, seniors' health, immigrants with legal status, people with disabilities, veterans, and more. Registration is free to maximize participation by the legal aid community.

#### Attendees

Primarily legal aid attorneys and pro bono counsel; also paralegals, navigators, and court/community partners.
